There is limited seating in Habernickel and swimmers will stay in the gym between events. Each team will be responsible for chaperoning their swimmers while they are in the gym. The gym will be cleared of swimmers and parents no later than 11:45 AM to allow YMCA programs to use the gym. Grannon Pool will be closed throughout the warm-up and meet.

Entry Deadline Date: Thursday 1 November 2007! • Send entries to: Bud Rimbault 112 Oak Street Ridgewood, New Jersey 07450 • If you are not e-mailing your entries, then overnight or express mail is recommended, <i>but waive the signature.</i> • It is not necessary to use overnight or express mail to send hard copy and check which are sent in support of an e-mailed entry.
<u>Meet Format Waiver:</u>	The host club has the right to change the format of the meet with the approval of the sanctioning chairman and age group chairman. These changes would be made for a more efficient swim meet for the swimmers and the host club. Reasons for these changes would be: <ul style="list-style-type: none"> • To allow more swimmers to swim. • To conform to facility capacity limits or for facility safety concerns. • To condense the meet into smaller time frame.

<u>Meet Requirement Statement:</u>	This meet qualifies as "one" of the three required short course meets to be eligible for the New Jersey SC Zone Championship Team.
<u>Coaches Eligibility:</u>	<ul style="list-style-type: none"> • All coaches "on the deck" must be members of USA Swimming. • Coaches must show coaching card for entrance to facility. • Coaches must show coaching card before picking up any meet information or scratch sheets. • Coaches must have coaching card visible at all times while on deck. • Coaches must have a visible coach's card when entering hospitality area or when asking for food at concessions.
<u>Swimmer Eligibility:</u>	<ul style="list-style-type: none"> • All swimmers must be members of USA Swimming to enter and compete in this meet. • All swimmers must be listed on a team's official entry form to be eligible to participate in this swim meet. • All transfer swimmer(s) must swim unattached for 120 days from their last attached competition. Swimmers must use an UN- (New Team Alpha Code) as their team affiliation. All Unattached swimmers must be listed on

	<p>the team's official waiver entry form.</p> <ul style="list-style-type: none"> • There are no time standards for this meet. • New Jersey Swimming only allows swimmers to enter and compete in 3 individual events per day. • Age for this meet is as of 11 November 2007.
<u>Meet Format:</u>	<ul style="list-style-type: none"> • This meet will be run in accordance to current USA Swimming Rules. • This meet will be run as a timed final meet. • This meet will be pre-seeded with all lanes and heats listed in the meet program.
<u>Meet Schedule:</u>	<ul style="list-style-type: none"> • The building will open at 6:30 AM. • Warm-up will divided team into two 30 minute sessions.

<u>Warm-up Procedures:</u>	<ul style="list-style-type: none"> • Warm-ups will be run under New Jersey Swimming Warm-up and Safety Guidelines. Warm-ups will include general warm-up lanes and sprint lanes. • All swimmers must enter the pool from the starting end of the pool. • New Jersey Swimming officials will monitor warm-ups. • All general warm-up lanes will swim in a counterclockwise direction. • The warm-up sessions will be two 30-minute warm-ups divided by teams. These two sessions will be followed by a 10-minute session of all sprint lanes.
<u>Entry Times:</u>	<ul style="list-style-type: none"> • New Jersey Swimming does not allow 'NT' or 'No Time' to be used as an entry time. • All entry times must be in short course yards.
<u>Check-In:</u>	<ul style="list-style-type: none"> • There will be no check-in for this meet. All events will be pre-seeded.
<u>Starts:</u>	<ul style="list-style-type: none"> • There will be no over the top starts used at this meet.
<u>Awards:</u>	<ul style="list-style-type: none"> • Medals will be awarded for the top 3 swimmers in each individual event.
<u>Entry Fees:</u>	<ul style="list-style-type: none"> • Individual Entry Fee: \$3.00 • Make checks payable to: Ridgewood YMCA
<u>Admissions and Programs:</u>	<ul style="list-style-type: none"> • Admission will be \$5.00 per adult, children 12&under are free. • Cost of Program will be \$3.00 for the entire meet.
<u>Entries:</u>	<ul style="list-style-type: none"> • In accordance with NJS policy, team entries may be submitted by E-mail to Bud Rimbault at brimbault@ridgewoodym.org. • All entries must be Hy-Tek program entries either on a 3 1/2" diskette or as an attached file to an e-mail. • The meet entry coordinator will respond to e-mails entries within 48 hours. If you do not receive an e-mail response within 48 hours, assume that your email has not been received. It then becomes the e-mailer's responsibility to make sure that the host club's meet entry coordinator receives the e-mail. If you do not receive an e-mail response, you must contact the entry coordinator by email or phone or mail in your entries. • An Entry Summary with a signed NJ Swimming waiver and a check must accompany or follow each mailed entry. • Accuracy of seed times is essential. Incomplete entries will not be accepted. • Deck entries will not be accepted. No phone or faxed entries will be accepted. • Team entries will be sent to each team via email.
<u>Results:</u>	<ul style="list-style-type: none"> • All Teams will be asked on the meet Summary whether they want results mailed or e-mailed.
<u>Host Club Responsibilities:</u>	<p>The host club responsibilities:</p> <ul style="list-style-type: none"> • The host club will provide all timers for each lane through out the meet. • The host club will e-mail all club entries back to the participating clubs.

	<ul style="list-style-type: none"> The host club will create a warm-up schedule that will be fair and equitable to all teams. This warm-up schedule will be e-mailed to all participating clubs no later than 72 hours before the meet.
<u>Participating Club Responsibilities:</u>	<ul style="list-style-type: none"> Participating club parents must stay off the pool deck. Participating clubs should help with officiating whenever possible. List the club contact for club officials on the meet summary.
<u>Concessions:</u>	There will be a concession stand with healthy and refreshing food and drinks available throughout the meet.
<u>Directions:</u>	Take the Garden State parkway north to exit 163. Then take Rt. 17 North to the Linwood Ave./Ridgewood exit. Continue over Rt. 17 on Linwood Ave. to the end. At the flashing light turn left, the YMCA will be a block and a half on the right. Turn right into the parking lot.
